Many of our products are made to order, personalized, or produced in small batches.

2. Ordering Process

Orders are confirmed only after receipt of payment and, where applicable, final design approval.

For custom projects:

- Initial inquiries are typically answered within 1–3 business days.
- First design drafts may take up to 10 business days after payment is received.
- Clients are responsible for providing accurate information and timely feedback.
- Delays in communication or approvals may impact project timelines.

3. Payment Terms

Payments are processed securely through trusted third-party payment providers.

Simply Noteworthy does not store or directly process full credit card information.

Unless otherwise agreed in writing, payment is due in full before production begins.

4. Refunds, Returns & Cancellations

Due to the custom, personalized, and made-to-order nature of our products, all sales are final.

We do not offer refunds, returns, or exchanges on custom, personalized, or made-to-order products.

Once payment has been received and production has begun, orders may not be canceled.

Clients are responsible for carefully reviewing proofs and approvals prior to production.

Simply Noteworthy is not responsible for errors approved during the proofing process.

Actual turnaround times may vary based on:

- Order volume
